
### **About Oregon QRIS Validation Study**

#### **Validation Study Purpose**

- ➤ Ask how well ratings measure quality or outcomes related to quality
- > Inform continuous improvement of QRIS

- Structural Indicators of Quality

#### **Study 1 (complete)**

 Quality of children's early learning experiences observations of adult-child interactions (Classroom Assessment Scoring System; CLASS)

#### **Study 2 (in-process)**

#### **Study 1 Measures**

#### **Classroom Assessment Scoring System (CLASS):**

PreK, Toddler, and Combined (mixed ages)

**Domains:** Emotional, Organizational (except toddler), Instructional

**QRIS rating data:** overall ratings, and ratings for each standard

Oregon Registry Online: more detailed measures of personnel education & training

Structural Indicators of Quality: Five quality measures created for all regulated facilities using administrative data

#### **Participants: Study 1**

#### **304 Programs**

Small Family Child Care	Large Family Child Care	Certified Centers
63 (21%)	92 (30%)	149 (49%)

81% participating in QRIS; 19% Level 1 (comparison group)


#### 1,084 Providers

- > 79% White, 12% Hispanic, 5% Asian, 3% Black, 2% American Indian, 1% Hawaiian, and 2% other
- Primary language: 84% English; 6% Spanish; 5% other




### Findings from study one

Overall Quality (CLASS) Scores




### Found Some Significant Associations between QRIS Ratings and CLASS Scores





## but not in Observations of Adult-Child Interactions.



## Findings from Comparison of QRIS Ratings and CLASS Scores

- QRIS ratings (1-2 vs 3-5) are modest-tomoderately linked with CLASS scores.
  - Most evidence for Instructional Support.
  - Fairly consistent across centers & family providers.
- Small home-based programs provided similar quality adult-child interactions as other types of programs, on average, yet their QRIS ratings were lower.

# **Examined Multiple Measures of Personnel Quality**

- High policy interest in association of personnel qualifications and quality
- Oregon has data on all persons working in regulated child care facilities, Oregon Registry Online (ORO)



# Study Included Three Distinct Sets of Personnel Quality Measures –All Built from ORO

- QRIS Personnel Quality ratings
- Structural Indicators of Quality
  - Only dataset that included level 1 providers
- VS Team Created Using Oregon Registry Online



# Provider Qualifications: Correlations of CLASS Scores with QRIS Ratings, ORO Measures, and Structural Indicators

# Training: Correlations of CLASS Scores with QRIS Ratings, ORO Measures, and Structural Indicators

Measure	Large Family Child Care	Small Family Child Care
QRIS Staff Training	IS+, OC	
ORO Staff Training	IS, OC+	ES, IS+, OC
SI Training Hours % => 20 hrs	ES	OC

# Retention and Accreditation: Correlations between CLASS Scores and Structural Indicators

Measure	Large Family Child Care	Small Family Child Care

## Findings from Comparison of Class Scores and Other Measures

- Modest to moderate correlations between CLASS scores and other quality measures:
  - Strengthen finding that personnel qualifications are associated with adult-child interactions.
  - Provide evidence that these non-observational measures are indicators of quality.
- Training emerges as important for small family child care training.
- Finding that retention correlated with Organized Classroom adds to conversation about value of experience.



## Structural Indicators of Quality and QRIS Ratings

- QRIS rating based on portfolio
  - Overall rating based on scores for standards within each domain
  - Available for programs that voluntarily participate
- Structural Indicators of Quality based on ORO and other administrative data
  - No overall score
  - Available for all regulated programs
  - Value for each of five quality indicators



## **Correlation of QRIS Ratings & Structural Indicators**

# Reflections on Correlations between SI Measures and Final QRIS Rating

 What is of interest is that measures constructed on all regulated programs using administrative data are so highly correlated with QRIS ratings based on portfolio



#### Limitations

- Relatively small number of small family child care homes in study limited ability to find significant differences that may have existed
- Limited research on Toddler and Combined CLASS
