





Hearing from the Field


- Held a virtual convening on April 11, 2023

Key Themes



^{*}Revised research protocols to incorporate COVID-19 context includes, for example, revising survey questions to ask about "before the pandemic" instead of "last year," and asking about the impact of COVID-19 on service delivery in interviews.



Recruitment Challenges

- All 9 projects faced recruitment issues
- Issues:
 - Extended or delayed timelines
 - Low response rates
 - Some participants being more/less able to participate
- Solutions:
 - Expanding recruitment criteria
 - Using pre-pay and post-pay tokens of appreciation/incentives



Context Setting: Some Implications of the Revised Methods for Future Studies



Care and Concern for Participants

- While considerations for research participants have always been a primary focus, researchers gained new perspectives on how to address the needs of participants during the pandemic:
 - Offering increased flexibility and timelines for recruitment
 - Providing more options for participation over a longer timeframe
 - Recognizing the many priorities for CCEE staff and families that took precedence over research activities



Recruitment and Participation

- Relying on CCEE programs to assist with recruitment and data collection can create additional burden on CCEE staff
- Research recruitment staff may need sensitivity training
- Importance of creating flexibility:
 - Submit OMB and IRB packages with multiple options for recruitment
 - Offer each participant the option of in-person or virtual participation
 - Understand and create solutions to support those more impacted by COVID-19 or with lower capacity to participate

Revised Research Activities الخيا

- Interviews and focus groups: offer evening and weekend times and technological support
- Classroom observations: both researchers and CCEE programs need significant technological support and solutions
- Child assessments: options for parent report, teacher report, or through an at-home data collection kit
- Staff training: in-person staff training for the research team is preferred

Some populations (e.g., rural participants, Tribal participants) less able to participate in research

Harder to build rapport with virtual data collection

Virtual recruitment is challenging

More challenging to train research/data collection staff remotely

Limited ability to interpret administrative data

What methods and procedures used during COVID-19 should be considered for future projects?

Use multi-modal recruitment

Build relationships with the community and partners

Offer pre-pay and post-pay tokens of appreciation

Build flexibility for various recruitment and outreach methods into OMB packages
